2 Definitions

Accepted industry practice refers to approved codes of practice and standardised procedures accepted by the wider wood manufacturing industry as examples of best practice.

Workplace procedures refer to documented policies and procedures set by the organisation carrying out the work, and to documented or other directions provided to staff, and applicable to the tasks being carried out. They may include but are not limited to – standard operating procedures, site specific procedures, site safety procedures, equipment operating procedures, quality assurance procedures, product quality specifications, references, approved codes of practice, housekeeping standards, environmental considerations, on-site briefings, supervisor's instructions, and procedures to comply with legislative and local body requirements relevant to the wood manufacturing industry sector.

3 Range

This unit standard applies to a daylight type press with removable caul plates only.

Outcome 1

Explain fundamentals of press caul plate changes.

Performance criteria

- 1.1 Reasons for changing press caul plates, and methods of installing and removing them are explained.
- 1.2 Hazards to personnel associated with changing press caul plates are explained.

	hydraulic fluid, heavy lifting, moving plant.

1.3 Safety practices associated with press caul plate changes are explained.

Outcome 2

Change press caul plates.

Performance criteria

2.1 Safe work practices associated with changing press caul plates are applied.

Range practices may include but are not limited to – isolation procedures, lock outs, plant access procedures, wearing of personal protective equipment.

- 2.2 Personnel required to complete the press caul plate change are notified and briefed.
- 2.3 Equipment required for the press caul plate change is assembled.
- 2.4 The press is prepared for the plate change.
- 2.5 The replacement caul plates are identified and transported from the storage area to the press.
- 2.6 Press caul plates are removed from the press and stored.
- 2.7 The replacement caul plates are installed in the press.
- 2.8 The press is prepared to return to operation.
