 - Range may include webbing, Velcro tape, Dacron tape, sticky back tape, vinyl, canvas, leather, polyvinyl chloride (PVC) patches.
- 1.3 Procedures for adding reinforcements are described.

Outcome 2

Demonstrate knowledge of fastener and fitting attachments used in the industrial textile fabrication industry.

Range may include – eyelets, domes, turnbuckles, rivets, studs, hooks, shock cord fastenings, rope end and splice clips, hook and loop, stayput, lift the dot, buckles, zippers, overcentre buckles, cam buckles, rave hooks, grommets, rings, rope, zips.

Performance criteria

- 2.1 Type and size of fasteners and fittings are described.
- 2.2 Applications for the attachments are described.
- 2.3 Methods for attaching fasteners and fittings are described.
