Outcome 1

Select materials for industrial textile fabrication.

- 1.1 Materials are selected and laid out for measuring and marking.
- 1.2 Material is checked for faults and quantity.

Outcome 2

Obtain dimensions for marking out materials for industrial textile fabrication.

Performance criteria

2.1 Dimensions and allowances are established.

Range may include – sketch, drawing, plan, sample, job specifications.

2.2 Individual panel sizes are determined.

Outcome 3

Measure and mark out material for industrial textile fabrication.

Performance criteria

- 3.1 Layout of panels is determined for the most economic use of material.
 - Range job specifications, fabric or material characteristics.
- 3.2 Panels are measured and marked out.
- 3.3 Panel alignment marks are applied.
- 3.4 Panels are marked for product and assembly identification.
- 3.5 Final material usage is recorded.
 - Range workbook, job card.
