 - Range layout, check measurements, clean area, adequate space, adequate lighting and ventilation, moving materials, checking cutting equipment, cutting list.
- 1.2 Bulk cutting method is described.
 - Range multi-layer, selvedge alignment, fabric length.
- 1.3 Single-layer cutting method is described.
 - Range fabric flat and even, fabric square.
- 1.4 Importance of labelling the cut pieces is explained.
 - Range assembly, storage, customer requirements.
