Industry guidelines refers to those practices and procedures commonly used as standard procedures to produce items of acceptable merchantable quality in the industrial textile fabrication industry such as related textbook descriptors. *Manufacturer's information* may include – technical information for a machine, or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

4 It is recommended that people seeking credit for this unit standard first hold credit for Unit 23504, *Demonstrate knowledge of adhesives, sealants, solvents hazardous materials used in industrial textile fabrication.*

Outcomes and performance criteria

Outcome 1

Use adhesives, sealants and waterproofing agents in industrial textile fabrication.

Range evidence of using two different adhesives, two different sealants and one waterproofing agent is required.

Performance criteria

- 1.1 Surface is prepared.
- 1.2 Adhesive, sealant or waterproofing agent is selected.
- 1.3 Adhesive, sealant or waterproofing agent is applied.

Outcome 2

Use solvents in industrial textile fabrication.

Range evidence of using two different solvents is required.

Performance criteria

- 2.1 Solvents are used.
- 2.2 Solvents are stored.

Outcome 3

Store and dispose of hazardous materials used in industrial textile fabrication.

Performance criteria

- 3.1 Storage areas in the workplace are used for the materials being stored.
- 3.2 Procedures that enable materials to be stored are complied with.
- 3.3 Procedures that enable hazardous waste to be disposed of are complied with.
