# **Explanatory notes**

#### 1 Definitions

Civil Defence Emergency Management (CDEM) means the application of knowledge, measures, and practices that are necessary or desirable for the safety of the public or property; are designed to guard against, prevent, reduce, or overcome any hazard or harm or loss that may be associated with any emergency; and includes, without limitation, the planning, organisation, co-ordination, and implementation of those measures, knowledge, and practices.

Organisation is an agency engaged in CDEM.

Section is a unit within an organisation's CDEM structure having a particular purpose (eg welfare or rescue).

- 2 Performance of the outcomes in this unit standard must comply with the Civil Defence Emergency Management Act 2002, and Health and Safety in Employment Act 1992.
- 3 Assessment against this unit standard may be conducted in a simulated emergency.
- The CDEM organisation's requirements or standard operating procedures (SOPs) refer to policies and procedures on safety and operation set down by each CDEM service employer or agency or host organisation.

# **Outcomes and evidence requirements**

#### **Outcome 1**

Describe CDEM operational orders, briefings, and debriefings.

# **Evidence requirements**

- 1.1 Description of CDEM operational orders, briefings, and debriefings is in terms of the nature of the CDEM exercise.
  - Range purpose, subject matter, timing, location, participants, methodology.
- 1.2 Description of CDEM operational orders, briefings, and debriefings is in terms of the roles and responsibilities of the personnel involved in the CDEM exercise.
  - Range may include but is not limited to team leader, team members, support services.
- 1.3 Description of CDEM operational orders, briefings, and debriefings procedures is in accordance with the organisation's SOPs.

#### Outcome 2

Conduct a CDEM operational briefing.

### **Evidence requirements**

- 2.1 Planning and preparation for the operational briefing are in accordance with the organisation's SOPs.
- 2.2 Operational briefing is conducted in accordance with the action plan and the organisation's SOPs.
- 2.3 Reports are prepared and communicated in accordance with the organisation's SOPs.

### **Outcome 3**

Issue CDEM operational orders.

### **Evidence requirements**

3.1 CDEM operational orders are issued in accordance with the organisation's SOPs.

#### **Outcome 4**

Conduct a CDEM operational debriefing.

### **Evidence requirements**

- 4.1 Planning and preparation of the debriefing are in accordance with the organisation's SOPs.
  - Range must include but is not limited to timeliness, location, incident information.
- 4.2 Operational debriefing is conducted in accordance with the organisation's SOPs.
- 4.3 CDEM operational debriefing addresses the outcome of the CDEM exercise.
- 4.4 Operational activity is evaluated and reviewed against the achieved outcomes and the desired outcomes as identified in the action plan.
- 4.5 Debriefing findings are summarised and reported in accordance with the organisation's SOPs.
