- 2 Definition
Company requirements refer to instructions to staff on policy and procedures which are communicated in an oral or in a written form. These requirements may include but are not limited to – manufacturer’s instructions, company safety requirements, throughput, and industry codes of practice and standards. Company requirements must include legislative requirements.
- 3 Range
 This unit standard applies to fin fish, crustaceans, kina, and paua but does not apply to bivalve shellfish.
- 4 All evidence presented in this unit standard must be in accordance with company requirements.

Outcomes and performance criteria

Outcome 1

Describe the preparation of, and prepare the transport unit to transport live fin fish.

Performance criteria

- 1.1 Describe the preparation of the transport unit and the reasons for this.
- Range may include but is not limited to – monitoring equipment, transport containers, oxygen supply, aeration system, water flow, valve functions, spillage collection, cleaning and disinfection, biosecurity, safety equipment, load security, documentation, communication; evidence of four is required.
- 1.2 Prepare the transport unit for transportation of live fin fish.
- Range may include but is not limited to – monitoring equipment, transport containers, oxygen supply, aeration system, water flow, valve functions, spillage collection, cleaning and disinfection, biosecurity, safety equipment, load security, documentation, communication; evidence of four is required.
- 1.3 Receive fin fish into the transport unit.
- Range may include but is not limited to – monitoring the species requirements, corrective action.

Outcome 2

Describe and carry out the transport and monitoring of live fin fish.

Performance criteria

- 2.1 Describe the monitoring requirements for transportation of live fin fish.
- Range may include but is not limited to – water quality, temperature, finfish behaviour, equipment, transport conditions, biosecurity.
- 2.2 Carry out the transport and monitoring of live fin fish and undertake required responses.
- Range may include but is not limited to – water quality, temperature, fish behaviour, equipment, transport conditions, biosecurity.

Outcome 3

Describe and carry out the post transport processes for live fin fish.

Performance criteria

3.1 Describe the process of unloading live fin fish from the transport unit, in terms of transporter's responsibilities.

Range may include but are not limited to – correct receiving location, set-up and operation of unloading equipment, monitoring of the species requirements, acclimatisation; evidence of two is required.

3.2 Describe the post unloading process.

Range may include but is not limited to – equipment, cleaning and disinfection, disposal of transport liquid and debris, biosecurity; evidence of two is required.

3.3 Carry out post transport processes for live fin fish.
