- 1 Legislation relevant to this unit standard includes but is not limited to:
 - Health and Safety at Work Act 2015; and any subsequent amendments.

2 Definitions

Organisational requirements – documented policies and procedures. These may include: equipment manufacturers' procedures, plant procedures, suppliers' instructions; site signage; codes of practice; company health and safety plans; on site briefings; and supervisor's instructions. This includes all regulatory and legislative obligations that apply to the plant.

PES (Personal Escape System) is an emergency escape system based on the abseiling principle.

- 3 For the purposes of assessment, evidence:
 - for the practical components of this unit standard must be supplied from the workplace;
 - for all outcomes must be presented in accordance with organisational requirements;
 - may be obtained in a simulated environment that closely reflects an offshore platform.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of the use, components, and operation of a PES.

Performance criteria

- 1.1 Describe a PES in terms of the situations in which it should be used.
 - Range evidence of two situations is required.
- 1.2 Identify and describe the components of a PES in terms of their purpose.
- 1.3 Describe the operational procedures for use of a PES in terms of achieving safe escapes.

Outcome 2

Demonstrate safe use of a PES from an offshore platform.

Performance criteria

- 2.1 Remove the PES unit from its storage position and interpret the instructions.
- 2.2 Check integrity of the security seal before use.
- 2.3 Remove the double action safety hook karabiner from the containment bag and attach to an appropriate anchor point.
- 2.4 Remove the triangular harness and controlling device and apply the harness.
- 2.5 Attach the containment bag to a secure anchor point.
 - Range rope length adjusted, decentre locked off.
- 2.6 Make a descent.
 - Range lock taken off, one hand on the un-weighted rope, descender utilised.
- 2.7 Use the quick release when sea level is reached.
- 2.8 Attach the PES to a life raft painter line.
