- 5 Definitions

Heavy Vehicle refers to classes MD3, MD4, ME, NB, TC and TD as specified in the Vehicle equipment standards classifications at

<u>standards/vehicle-classes/</u>; or has a gross vehicle mass that exceeds 3500kg and is not of a class specified in the Vehicle equipment standards classifications. *Service information* refers to information such as technical information for a vehicle, machine, or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations. *Suitable tools and equipment* refer to industry approved tools and equipment that are recognised within the industry as being the most suited to complete the task in a professional and competent manner with due regard to safe working practices.

6 Range

This unit standard includes a minimum of one of the following disc braking systems – rotor calliper type, single wet or dry type, multi-plate wet or dry type.

Outcomes and performance criteria

Outcome 1

Inspect heavy vehicle and equipment disc brakes.

Performance criteria

- 1.1 The disc brake system is visually inspected.
- 1.2 Brake components are inspected for condition.
 - Range may include calliper, brake activator, pads, plate linings, rotor, friction plates, guides and splines, housing assembly.
- 1.3 Brake components are removed.
- 1.4 Activating mechanisms are inspected.

Outcome 2

Repair heavy vehicle and equipment disc brakes.

Performance criteria

- 2.1 Activating mechanisms are repaired or replaced.
- 2.2 Disc brake components are repaired or replaced and reassembled.
- 2.3 The operation of the system is checked, and any adjustments and repairs carried out.
