Outcome 1

Compare definitions and theories of disability and aging.

Performance criteria

- 1.1 Definitions of disability are compared for similarities and differences.
Range three definitions.
- 1.2 Definitions of aging are compared for similarities and differences.
Range three definitions.
- 1.3 A disability theory and an aging theory are compared for approaches to diversity.
Range four of – age, gender, class, sexuality, sexual orientation, race, ethnicity, deprivation.

Outcome 2

Identify and describe historical approaches to disability or aging in Aotearoa New Zealand.

Range analysis is required of one population in Aotearoa New Zealand, and may include – disabled people, older people, mental health populations, or ethnic and cultural groups.

Performance criteria

- 2.1 Historical approaches to disability or aging at national, regional, and local levels are identified and described.
- 2.2 Historical terminology, attitudes, stereotypes, and barriers are identified and described.
- 2.3 Historical service provision and access frameworks are identified and described.

Outcome 3

Identify and describe the impairments, conditions, rights, and needs of a specific group of disabled or older people.

Performance criteria

- 3.1 The consequences of an impairment or disability type are identified and described for a specific group of people.
- 3.2 A disease pathway and consequences of an impairment or disability type are identified and described for a specific group of people.
- 3.3 Family dynamics and the ways in which specific groups of people interact and respond to stressors are identified and described.

Outcome 4

Compare international policy developments in disability and aging with practices used in Aotearoa New Zealand.

Range evidence is required from two countries outside Aotearoa New Zealand.

Performance criteria

- 4.1 International policies are identified and described in terms of similarities and differences to policies in Aotearoa New Zealand.

Range one description covering disability policies; one description covering aging policies.
- 4.2 International policies for service delivery are outlined and described in terms of their similarities and differences to policies in Aotearoa New Zealand.

Range one description covering service delivery of disability policies; one description covering service delivery of aging policies.

Outcome 5

Compare models of assessment, planning, and coordination practice for working with a specific group of disabled or older people.

Range two models that cover assessment, planning, and co-ordination; models may include but are not limited to – strength-based models, social role valorisation, rights, entitlements, needs assessment and service coordination, case management, care coordination.

Performance criteria

- 5.1 The strengths and weaknesses of each model are described and compared.

- 5.2 Intended outcomes for the specific group of disabled or older people are identified and compared.
