### **Guidance Information**

## 1 Definitions

Ambulance context – situations where emergency care is delivered in a variety of out-of-hospital environments. Out-of-hospital environments refer to any situation in which people require medical assistance outside of a controlled medical environment, such as a medical centre. These out-of-hospital environments include situations both in and away from an ambulance vehicle.

Best practice – for the purposes of this standard, a clinical technique or methodology that has proven to be most effective at delivering a desired outcome and is actively promoted across the ambulance and/or emergency care sector.

Clinical procedures and guidelines – the written procedures particular to each ambulance service and endorsed by Ambulance New Zealand.

Standing orders – written instructions issued by a medical practitioner that authorise individuals engaged in the delivery of health services to supply and administer certain medicines without a prescription in circumstances specified in the instruction.

#### Outcome 2

Demonstrate knowledge of common acute paediatric conditions, their signs, symptoms, and differential diagnoses, for an ambulance context.

#### Performance criteria

2.1 Describe common acute paediatric conditions according to their pathophysiology.

Range includes but is not limited to – croup, bronchiolitis, asthma, upper

respiratory tract infections, trauma, meningococcal septicaemia.

- 2.2 Describe signs and symptoms of common acute paediatric conditions.
- 2.3 Describe differential diagnoses for common acute paediatric conditions.

### **Outcome 3**

Develop a management plan for a paediatric patient with an acute condition in an ambulance context.

### Performance criteria

- 3.1 Describe the general management steps for paediatric patients with acute conditions.
- 3.2 Describe specific techniques used in the management of paediatric patients with acute conditions according to purpose and content for their different age groups.

Range may include but is not limited to – approach, language.

3.3 Develop, explain, and justify a management plan for a paediatric patient with an acute condition.
