1 Definitions

Health and safety requirements refer to the documented safety plan for the workshop or site which is required to ensure compliance with the requirements of the Health and Safety in Employment Act 1992, and the Health and Safety in Employment Regulations 1995.

Specifications refer to documented instructions (oral, written, graphic) and may include the following: specifications from a supervisor or project specific drawings or requirements.

Workplace practice refers to the documented procedures specific to a work site which set out the standard and required practices of that work place. For this unit standard, *workplace* includes residential dwellings.

- 2 Evidence for achieving credit in this unit standard can be presented in conjunction with meeting the outcomes of other unit standards in the *Basic Residential Property Maintenance* domain or related domains at Level 2.
- 3 Tasks to be performed as evidence for this unit standard include:
hack out and re-putty window frames, install replacement glass, hang a mirror, use rubber strips to re-glaze an aluminium frame.
- 4 Legislation relevant to this unit standard includes:
Health and Safety in Employment Act 1992;
Health and Safety in Employment Regulations 1995.

Elements and performance criteria

Element 1

Prepare to perform basic glazing maintenance in a residential dwelling.

Performance criteria

- 1.1 The work to be performed is described in terms of specifications.
Range location, job requirements, standard of workmanship.
- 1.2 Quantities of materials are calculated from job specifications.
- 1.3 Tools, equipment, and personal protective equipment (PPE) are identified and selected to match the job requirements.

Element 2

Perform basic glazing maintenance in a residential dwelling under supervision.

Performance criteria

- 2.1 Work is carried out and finished in accordance with job specifications.
- 2.2 Tools, equipment, and PPE are used in accordance with health and safety requirements and work place practice.

Element 3

Complete work operations under supervision.

Performance criteria

- 3.1 Tools, equipment, and PPE are maintained and securely stored to prevent tampering and theft in accordance with health and safety requirements and work place practice.
- 3.2 Site is cleared of all surplus components, equipment, tools and debris in accordance with health and safety requirements and work place practice.

Please note

Providers must be accredited by NZQA, or an inter-institutional body with delegated authority for quality assurance, before they can report credits from assessment against unit standards or deliver courses of study leading to that assessment.
