Guidance Information

- 1 Definitions

Legislative requirements refer to the obligations of the employer and/or employee under the Health and Safety at Work Act 2015 and Health (Hairdressers) Regulations 1980.

Workplace requirements mean the practices prescribed by management as being the quality standards for client contact and work organisation for a particular salon.
- 2 In this unit standard all work must comply with legislative requirements and must ensure optimum hair condition and maximum client comfort at all times.
- 3 Troughs of waves must be no larger than the candidate’s two finger widths.
- 4 Prepared hair includes analysis of hair including growth patterns.

Outcomes and performance criteria

Outcome 1

Describe elements of wave patterns.

Performance criteria

- 1.1 Elements of wave patterns are described.

Range crest, trough, circle.

1.2 Parts of a fingerwave are identified.

Range open end, closed end.

Outcome 2

Fingerwave hair using moulding techniques.

Range evidence is required for vertical, diagonal, and horizontal fingerwaves.

Performance criteria

2.1 Direction of hair growth is analysed to establish the appropriate fingerwave pattern and either a vertical, horizontal or diagonal fingerwave direction is chosen to match hair growth pattern.

2.2 The client is protected against water and/or product spillage.

2.3 Prepared hair is able to be fingerwaved from roots to ends.

Range includes breaking hydrogen bonds.

2.4 Assembled tools match fingerwaving requirements.

Range tail comb, cutting comb, pincurl clips.

2.5 Manipulated hair flows in a fingerwave movement.

2.6 Full head of fingerwaves is finished with two rows of pincurls that follow fingerwave pattern.

2.7 Placement of fingerwaves and pincurls is completed within forty minutes.

Range the completion of evidence requirements 2.5 and 2.6 is included within the forty minute timeframe.

Outcome 3

Dry and dress hair.

Performance criteria

3.1 Hair is prepared for drying in a manner which ensures maximum client protection and comfort.

3.2 Hair is dried in a manner which causes no damage to hair and ensures that the client's safety and comfort is maintained.

3.3 Styling aids are removed from hair ensuring maximum hair protection and client comfort.

3.4 Hair is dressed to confirm that the intended fingerwave result has been achieved.

Range hair to be brushed from roots to tips prior to dressing.

Outcome 4

Complete follow up actions.

Performance criteria

4.1 Homecare advice provided is consistent with client’s hair type and completed service.

Range product type, hair maintenance.

4.2 Tools and equipment are sanitised in accordance with workplace requirements.

4.3 The work area is cleaned and tidied in accordance with workplace requirements.

Range work area – shampoo area, styling station.
