#### 2 Assessment

This unit standard is for experienced people who work in a joinery workshop in a management position. Evidence for this standard must reflect professional competence confirmed by a person with current expertise in the joinery trade.

Professional competence refers to the ability to work independently to meet the ethical and professional expectations of industry and clients on dynamic and varied projects operating in a commercial environment.

3 Definition

*Workplace requirements* refer to the documented procedures specific to a workplace which set out the standard and the required practices of that workplace. This may include job specifications, procedures, practices, manufacturer recommendations, technical data sheets and material safety data sheets.

# Outcomes and performance criteria

### Outcome 1

Monitor job progress to align with work production schedules for joinery manufacture.

## Performance criteria

- 1.1 Work production schedules are developed to ensure approved work is assigned to appropriate personnel in accordance with workplace requirements.
- 1.2 The progress of the job is monitored to ensure work schedules are being met in accordance with workplace requirements.
- 1.3 The contract or sub-contract is completed by the due date in accordance with workplace requirements.

# Outcome 2

Monitor quality of work for joinery manufacture.

### Performance criteria

- 2.1 The materials used are as detailed in the job specification.
- 2.2 The workmanship conforms to standard trade practice and as detailed in the job specification.
- 2.3 Machine tooling is checked to ensure that the tooling is compatible with materials used in accordance with industry practice.

### Outcome 3

Liaise with other contributing parties to monitor contract progress for joinery manufacture.

#### Performance criteria

- 3.1 Communication is maintained with all parties associated with the work to ensure that the contract meets the time schedule in accordance with workplace requirements.
- 3.2 Liaison with technical specialist is maintained to ensure contractual requirements are met in accordance with workplace requirements.

### Outcome 4

Maintain documentation for joinery manufacture.

### **Performance criteria**

- 4.1 Work records are maintained to meet company, business, and legal requirements in accordance with workplace requirements.
- 4.2 Quality documentation is maintained to meet company, business, and legal requirements in accordance with workplace requirements.
