Performance of the elements of this unit standard must fit within these broad parameters.
- 3 It is recommended that prior to assessment for this unit standard, candidates have achieved Unit 23918, *Describe diversional and recreational therapy*, or are able to demonstrate equivalent skills and knowledge.

**4 Definitions**

*Research* refers to accessing and using information from a variety of sources that may include – written information, client support information, interviews.

*Self-developed resource manual* refers to those documents and/or handbooks used and/or compiled, and continually updated, by individual diversional therapists as personal professional reference material.

**5 Evidence is required for resources in the candidate's local area.**

**Outcomes and performance criteria****Outcome 1**

Research community support services as a resource to assist diversional therapists.

Range services includes but are not limited to – community workers, social workers, needs assessors, service coordinators, other diversional therapists, occupational therapists, Age Concern, Alzheimer's New Zealand.

**Performance criteria**

- 1.1 Research identifies services that can assist diversional therapists to support an individual.
- 1.2 Research identifies how services can support an individual directly.
- 1.3 Research identifies how service organisations can provide support for an individual with specific needs.
- 1.4 Research identifies the accessibility and costs of service organisations.

**Outcome 2**

Collate documentation from the research findings into a self-developed resource manual.

**Performance criteria**

- 2.1 Documentation includes information about how services can assist diversional therapists to support an individual.
- 2.2 Documentation includes information about how services can support an individual directly.
- 2.3 Documentation includes information about the purpose of service organisations.
- 2.4 Documentation includes information about service organisations' accessibility and costs to the individual and diversional therapists.
- 2.5 Self-developed resource manual is logically organised, up-to-date, and in a manner that allows easy access to information.
