Title	Dress long hair using integrated techniques

Purpose	This unit standard is for people in the hairdressing industry to further develop their long hair styling and maintenance skills.
	 People credited with this unit standard can: identify long hair techniques, prepare to dress long hair, dress long hair into a variety of styles, and complete the service experience.

Guidance Information

1 Definitions

A *commercially acceptable timeframe* varies for different hairdressing services. Times reflect performance required to support a commercial salon's profitability. *Legislative requirements* refer to the obligations of the employer and/or employee under the Health and Safety at Work Act 2015 and Health (Hairdressers) Regulations 1980.

Workplace requirements mean the practices prescribed by management as being the quality standards for client contact and work organisation for a particular salon.

- 2 In this unit standard all work must comply with legislative requirements and health and safety best practice, and must ensure optimum hair condition and maximum client comfort at all times.
- 3 Range

Assessment against this unit standard requires evidence of a classic French roll (including back combing), and one other long hair up style that incorporates a variety of techniques. Other techniques to be used may include but are not limited to pin curls, twists, petals, knots, ponytails, braids. Hair pieces, extensions, padding or adornment may be used.

A commercially acceptable timeframe varies for different hairdressing services. Times reflect performance required to support a commercial salon's profitability. A commercially acceptable timeframe to dress and finish the hair is a maximum of fortyfive minutes.

4 Essential underpinning skills and knowledge for this standard are covered by Unit 33229, Use design fundamentals to create plans for constructing hairstyles.

Outcomes and performance criteria

Outcome 1

Identify long hair techniques.

Performance criteria

1.1 Long hair techniques are identified.

Range must include but is not limited to – pin curls, twists, petals, knots, French roll, ponytails, braids.

Outcome 2

Prepare to dress long hair.

Performance criteria

- 2.1 Service outcome is identified and confirmed in consultation with the client, and client is protected for the required service in accordance with any manufacturer's instructions and the expectations of the salon environment.
 - Range consultation must include pre-quoting (time, money), service journey, time allowances, maintenance.
- 2.2 The hair and scalp are analysed.

Range porosity, elasticity, texture, density, length, scalp conditions, growth patterns, medical or other factors that can affect the skin.

- 2.3 The style to be dressed is selected in accordance with confirmed outcome and compatibility with hair and scalp analysis.
- 2.4 Hair is prepared for dressing correctly using styling tools in accordance with confirmed outcome.
- 2.5 Pre-styling is carried out to meet the confirmed outcome.

Outcome 3

Dress long hair into a variety of styles.

Performance criteria

- 3.1 Dressing techniques are demonstrated to meet the design outcome.
- 3.2 Styling materials and tools are selected and used to produce the selected style without damaging hair.
- 3.3 Hair is dressed and finished using techniques that achieve design outcome.

3.4 Hair is dressed and finished within a commercially acceptable timeframe.

Outcome 4

Complete the service experience.

Performance criteria

4.1 Specialised long hair advice is provided consistent with client's completed service.

Range hairstyle product recommendations.

- 4.2 Tools and equipment are sanitised in accordance with workplace requirements.
- 4.3 The work areas are cleaned and tidied in accordance with workplace requirements.
