Range may include but is not limited to receiving seafood product from – vessel, marine farm, another plant, import, depot, store; evidence of one type of seafood product from one source is required.

Performance criteria

- 1.1 Describe the checks carried out when receiving seafood product into the seafood operation.
- 1.2 Describe the documentation required when receiving seafood product into the seafood operation.

Outcome 2

Demonstrate knowledge of the documentation and seafood product checks when dispatching seafood product from the seafood operation.

Range may include but is not limited to dispatching seafood product to – another plant, store, freight forwarder, market; evidence of one type of seafood product to one destination is required.

Performance criteria

- 2.1 Describe the checks carried out when dispatching seafood product from the seafood operation.
- 2.2 Describe the documentation required when dispatching seafood product from the seafood operation.

Outcome 3

Carry out the seafood product checks and complete documentation for the movement of seafood product.

Range reception, dispatch.

Performance criteria

- 3.1 Carry out the product checks required, and take action if issues are identified, when moving seafood product.
- 3.2 Complete the documentation required when moving seafood product.
