Performance criteria

- 2.1 Card machine mechanism is removed or disassembled to enable replacement or repair.
- 2.2 Card machine mechanism and components are assessed for replacement or repair.
- 2.3 Replacement or repair is carried out.
- 2.4 Mechanism is reassembled or replaced on card.
- 2.5 Repaired mechanism is reset and/or tuned to operate to machine specification.
- 2.6 Card is tested and retuned for optimum performance.
