- 1 Definition  
*Establishment requirements* refer to applicable procedures found in the following: establishment performance guidelines and standards; equipment manufacturer's procedures and specifications; Government and local body legislation.
- 2 Legislation to be complied with includes but is not limited to – Hazardous Substances and New Organisms Act 1996, Health and Safety at Work Act 2015.
- 3 For the purpose of this unit standard, service supply areas must be kept hygienically clean, tidy, and free from rubbish at all times, and secure from unauthorised people, in accordance with establishment requirements.
- 4 Evidence for the practical components of this unit standard must be gathered in the workplace.

### Outcomes and performance criteria

#### Outcome 1

Provide an establishment off-site laundry service in a commercial hospitality establishment.

#### Performance criteria

- 1.1 Establishment laundry is collected and actioned in accordance with establishment requirements.

- 1.2 Documentation and recording processes for establishment laundry are maintained in accordance with establishment requirements.
- 1.3 Communication is maintained with providers of off-site laundry services to ensure clear understanding of establishment requirements.
- 1.4 Establishment laundry is checked to ensure it is clean, complete, and undamaged in accordance with establishment requirements.
- 1.5 Storage area for establishment laundry is kept free from infestation in accordance with establishment requirements.
