- 2.4 GPS approach procedure is demonstrated in accordance with industry texts and standards.
- 2.5 GPS missed-approach procedure is demonstrated in accordance with industry texts and standards.

Outcome 3

Demonstrate specific knowledge of the GPS unit in use.

Performance criteria

3.1 Specific knowledge of the GPS unit in use is demonstrated in accordance with industry texts and standards.

Outcome 4

Demonstrate knowledge of the privileges, procedures, and limitations with respect to the use of GNSS under IFR.

Performance criteria

4.1 Knowledge of privileges and procedures is demonstrated with respect to the use of GNSS under IFR in accordance with CAA Rules and Advisory Circulars.
