- 2 Definition

- 3 Assessment information

Evidence presented for assessment against this unit standard must be consistent with safe working practices and be in accordance with applicable service information, workplace procedures and legislative requirements.

Outcomes and performance criteria

Outcome 1

Wash up a reel-fed printing press.

Performance criteria

- 1.1 Wash up press using the selected solvents.
- Range may include – inking system, dampers, damping units, blankets, impression cylinders, bearers.
- 1.2 Reclaim ink from ducts or pumps and return to store for re-use, or disposal.
- 1.3 Clean and store ancillary press equipment used during the production run.
- 1.4 Clean and check image for wear and damage and rectify and report any faults or defects.
- 1.5 Dispose of image carriers or prepare for storage and store.
- 1.6 Follow waste control procedures.
- Range recyclable waste, waste disposal, security waste.
