*On-carriage* refers to passengers and baggage transferring onto a further flight, within the same day or within 24 hours, to their destination e.g. Auckland/Sydney/Johannesburg.  
*In-carriage* refers to passengers and baggage transferring to their destination, within the same day or 24 hours, after arriving e.g. Auckland/Wellington/Timaru.

- 1.1 The terms on-carriage and in-carriage are explained.
- 1.2 Situations requiring on-carriage to be added into the DCS are identified.
- 1.3 Reasons on-carriage and in-carriage are required in the DCS are identified.
- 1.4 On-carriage exceptions are identified.

**Outcome 2**

Demonstrate knowledge of on-carriage and in-carriage entries used in the DCS.

**Performance criteria**

2.1 Entries used in the DCS for on-carriage and in-carriage are identified.
