- 2.3 The item is examined and any pre-existing damage is recorded.

Range may include but is not limited to – broken handles, straps or latches, scratches, dents, rips, tears.

- 2.4 Limited release tag is completed.
- 2.5 Tags are attached to the item.
 - Range may include but is not limited to limited release tag, fragile tag, heavy item tag.
- 2.6 The item is introduced into baggage system.
 - Range may include but is not limited to baggage belt, baggage trolley, storage area.
