4 Definitions

*Electronic scanning equipment* – walk-through and hand-held devices. *Local rules* – site-specific written rules, instructions, or procedures that specify how any irradiating apparatus is to be used and/or stored to ensure safety for all. *Organisational policies and procedures* refer to the formal policies and procedures for a specific prison site and its activities, and which are consistent with its lead organisation.

*Prison environment* – any area, within a prison site or external to a prison site where prisoners are held, such as a cell block, within the prison perimeter, on a prison farm, or in a vehicle transporting prisoners.

Site Radiation Safety Plan – plan for the implementation of radiation safety which includes the local rules.

*Unauthorised items* – items that prisoners must not have access to within prisons in accordance with sections 3 (unauthorised items) and 43(2) of the Corrections Act 2004.

# Outcomes and performance criteria

### Outcome 1

Describe legislation relevant to the use of x-ray and electronic scanning equipment when searching individuals and property within a prison environment.

### Performance criteria

- 1.1 Describe legislation relevant to using x-ray and electronic scanning equipment when conducting searches.
  - Range person and item searches, unauthorised deliveries, communications, recordings, possession of unauthorised items.
- 1.2 Describe legislative authorisations and restrictions for use of x-ray and electronic scanning equipment in searches within a prison.
- 1.3 Describe legislative requirements for searches and detentions in a prison.

Range cautioning detainees, advising detainees of their rights.

1.4 Describe use of x-ray equipment in terms of local rules.

### Outcome 2

Describe the use of x-ray and electronic scanning equipment for searching individuals and property in a prison environment.

### Performance criteria

2.1 Describe key roles and responsibilities relevant to x-ray and electronic scanning searching in accordance with organisational policies and procedures.

- 2.2 Describe the roles of prison staff when operating x-ray equipment in accordance with organisational policies and procedures.
- 2.3 Describe policies and procedures for use of x-ray and electronic scanning equipment used for searches in accordance with organisational policies and procedures.
  - Range staff, visitors, contractors, persons in wheelchairs, persons with infant or toddler carriage(s).
- 2.4 Describe policies and procedures and requirements for dealing with persons who refuse to submit to an electronic scanning or x-ray search in accordance with organisational policies and procedures.
  - Range refusal before being admitted to prison, refusal while in prison, refusal from a person other than a private visitor.
- 2.5 Describe the procedures for recording and documenting searches in accordance with organisational policies and procedures.
- 2.6 Describe exhibit handling and management procedures in accordance with organisational policies and procedures.

## Outcome 3

Describe legislation relevant to the ownership and use of x-ray equipment.

## Performance criteria

- 3.1 Describe legislation and regulations relevant to the ownership and use of x-ray equipment.
- 3.2 Describe responsibilities for compliance with the Site Radiation Safety Plan.

## Outcome 4

Describe radiation safety when operating x-ray equipment in prison.

## Performance criteria

- 4.1 Describe safe radiation dosage rates and their measurements in accordance with equipment manufacturer instructions.
- 4.2 Describe actions to be taken in case of emergency in accordance with organisational policies and procedures.
- 4.3 Describe measures to prevent tampering with x-ray equipment by unauthorised persons in accordance with organisational policies and procedures.
- 4.4 Describe correct use of labels and warning signs in the vicinity of x-ray equipment in accordance with the facility-specific radiation safety plan.

### Outcome 5

Operate and maintain x-ray and electronic scanning equipment in a prison environment.

### Performance criteria

- 5.1 Operate x-ray equipment in accordance with organisational policies and procedures.
- 5.2 Recognise and highlight contraband utilising the x-ray equipment.

Range image enhancement keys, zoom key.

5.3 Conduct electronic scanning searches of individuals entering a prison site in accordance with organisational policies and procedures.

Range electronic scanners – walk through metal detector or hand-held metal detector.

- 5.4 Monitor visual and auditory alarms and respond in accordance with organisational policies and procedures.
- 5.5 Maintain x-ray and electronic scanning equipment in accordance with organisational policies and procedures.
- 5.6 Perform basic trouble-shooting on x-ray equipment in accordance with manufacturer instructions.
