<b>Critical health and safety prerequisites</b>	Industry requirements are that the candidate must meet the eligibility requirements of the Civil Aviation Act 1990 and the Civil Aviation Rules Part 61 for a flight instructor rating.

### Explanatory notes

- 1 This unit standard is aligned with the relevant parts of the prescribed requirements of the Civil Aviation Authority of New Zealand (CAA) under CAA Rules Part 61 and Advisory Circular 61.18 for a Category C flight instructor rating (helicopter). Credit will be awarded on meeting the requirements of the CAA-approved assessment or examination.

- 3 All references to the CAA refer specifically to the Civil Aviation Authority of New Zealand.
- 4 Industry standards and recommended practices are those set in place by the CAA.
- 5 Industry texts may include but are not limited to – aircraft flight manuals, CAA Rules, CAA Advisory Circulars, CAA Flight Test Standards Guides, operator exposition.

- 6 For the purpose of this unit standard, *knowledge* refers to the knowledge, understanding, and application of the subject matter.

## Outcomes and evidence requirements

### Outcome 1

Fly a helicopter as a pilot-in-command to show preparedness for a Category C flight instructor rating.

#### Evidence requirements

- 1.1 Flying is demonstrated in accordance with industry texts and standards.

Range appropriate aircraft category, specific flight acceptable to Director of CAA.

### Outcome 2

Demonstrate knowledge of the theory and practice of flight instruction to show preparedness for a Category C flight instructor rating.

#### Evidence requirements

- 2.1 Flight instructional theory and practice are described and explained in accordance with industry texts and standards.

### Outcome 3

Demonstrate knowledge of theory subjects to show preparedness for a Category C flight instructor rating.

#### Evidence requirements

- 3.1 Theory subjects are analysed and explained in accordance with industry texts and standards.

Range helicopter principles of flight and performance, meteorology, cross-country navigation techniques, the theory and practice of flight instruction.

### Outcome 4

Demonstrate dual flight instructor skills to show preparedness for a Category C flight instructor rating.

**Evidence requirements**

4.1 Dual flight instructor skills are demonstrated in accordance with industry texts and standards.

Range may include but is not limited to – dual flight instructor training, equivalent training.

**Outcome 5**

Demonstrate flight instruction to show preparedness for a Category C flight instructor rating.

**Evidence requirements**

5.1 Flight instruction is demonstrated in accordance with industry texts and standards.

Range appropriate aircraft type, normal manoeuvres, emergency manoeuvres.
