- 2 Definition
Worksite requirements refer to job instructions to candidate on agreed work to be carried out.
- 3 This unit standard must be assessed against in a realistic workplace environment. The candidate must be under realistic time pressures, and use relevant commercial equipment and approved industry techniques.
- 4 Range
substrate surfaces include – masonry, timber, steel, plaster board;
paint includes – acrylic, oil-based enamel, acrylic enamel;
surfaces include – doors, windows, skirtings, walls.
- 5 Evidence is required of a minimum of an application on each of the substrate surfaces in the range.

Outcomes and performance criteria

Outcome 1

Plan and prepare to apply paint to multiple surfaces.

Performance criteria

- 1.1 Work instructions and operational details are obtained and confirmed in accordance with worksite requirements.
- 1.2 Safety instructions are followed in accordance with worksite and legislative requirements.
- 1.3 Signage and barricade requirements are identified and implemented in accordance with worksite and legislative requirements.
- 1.4 Tools and equipment are selected to meet the job requirements, and checked for serviceability prior to commencement of work in accordance with worksite requirements.
- 1.5 Material quantities are calculated to meet the job requirements in accordance with worksite requirements.
- 1.6 Any environmental requirements are identified in accordance with worksite and legislative requirements.

Outcome 2

Prepare work area and materials for painting multiple surfaces.

Performance criteria

- 2.1 Materials are prepared and substrate surface checked in accordance with manufacturer's specifications and worksite requirements.
- 2.2 Adjoining areas to application area are protected in accordance with worksite requirements.
- 2.3 Ventilation is provided in application area to maintain safety of self and others in accordance with worksite and legislative requirements.
- 2.4 Measures are taken to ensure application area is dust free in accordance with worksite requirements.
- 2.5 Materials for paint finish are mixed and stirred to specified proportion and consistency in accordance with manufacturer's specifications and worksite requirements.
- 2.6 Amounts of paint material are prepared to specified ratio and drying time in accordance with manufacturer's specifications and worksite requirements.

Outcome 3

Apply paint with brush and roller to multiple surfaces.

Performance criteria

- 3.1 Brush and roller is selected for specified surface profile, size of area, type of paint and finish required in accordance with manufacturer's specifications and worksite requirements.
- 3.2 Paint is applied to achieve required level of opacity, finish, texture and sheen in accordance with manufacturer's specifications and worksite requirements.
- 3.3 Finished paint surface is cured in accordance with manufacturer's specifications and worksite requirements.
- 3.4 Any doors, windows and furniture removed for painting application are re-installed without damage to painted surfaces in accordance with worksite requirements.

Outcome 4

Clean up and store painting equipment.

Performance criteria

- 4.1 Unused materials are sealed and stored in accordance with worksite and legislative requirements.
- 4.2 Work area is cleared and materials are disposed of, reused, or recycled in accordance with worksite and legislative requirements.
- 4.3 Tools and equipment are cleaned, checked, maintained and stored in accordance with manufacturer's specifications and worksite requirements.
