- 4 Evidence is required of a minimum of five jobs requiring stains and clear timber finishes.

# Outcomes and performance criteria

# **Outcome 1**

Plan and prepare to apply stains and clear timber finishes.

# Performance criteria

- 1.1 Work instructions and operational details are obtained and confirmed in accordance with worksite requirements.
- 1.2 Safety instructions are followed in accordance with worksite and legislative requirements.
- 1.3 Signage and barricade requirements are identified and implemented in accordance with worksite and legislative requirements.
- 1.4 Tools and equipment are selected to meet the job requirements, and checked for serviceability prior to commencement of work in accordance with worksite requirements.
- 1.5 Material quantities are calculated to meet the job requirements in accordance with worksite requirements.
- 1.6 Any environmental requirements are identified in accordance with worksite and legislative requirements.
- 1.7 Stain colour to be applied is matched to previously treated timber or associated area or item in accordance with worksite requirements.

#### Outcome 2

Prepare materials and application area for applying stains and clear timber finishes.

# Performance criteria

- 2.1 Area is set up for application processes to suit application system being used in accordance with worksite requirements.
- 2.2 Adjoining surfaces to application area are protected in accordance with worksite requirements.
- 2.3 Ventilation is provided in application area to maintain safety of self and others in accordance with worksite and legislative requirements.
- 2.4 Measures are taken to ensure application area is dust free in accordance with worksite requirements.
- 2.5 Existing stained or finished surfaces for application are stripped in accordance with worksite requirements.

#### **Outcome 3**

Stain bare timber surfaces.

# Performance criteria

- 3.1 Stain is selected for type of timber allowing for aesthetics and durability in accordance with manufacturer's specifications and worksite requirements.
- 3.2 Stain is prepared to proportions and consistency in accordance with manufacturer's specifications and worksite requirements.
- 3.3 Application method for the specified surface area, size and type of finish is selected in accordance with manufacturer's specifications and worksite requirements.
- 3.4 Stain is applied to bare timber surface in accordance with manufacturer's specifications and worksite requirements.
- Wood filler and putty are selected, mixed, colour matched and applied to timber in accordance with manufacturer's specifications and worksite requirements.

#### **Outcome 4**

Apply clear timber finishes.

### Performance criteria

- 4.1 Coats of selected clear finish are applied to achieve required level of opacity, coverage and sheen in accordance with manufacturer's specifications and worksite requirements.
- 4.2 Drying time is allowed between coats in accordance with manufacturer's specifications and worksite requirements.
- 4.3 Clear finish surfaces are cured in accordance with manufacturer's specifications and worksite requirements.

# **Outcome 5**

Clean up and store equipment used for applying stains and clear timber finishes.

# Performance criteria

- 5.1 Unused materials are sealed and stored in accordance with worksite and legislative requirements.
- Work area is cleared and materials are disposed of, reused, or recycled in accordance with worksite and legislative requirements.
- Tools and equipment are cleaned, checked, maintained and stored in accordance with manufacturer's specifications and worksite requirements.
