### **Guidance Information**

### 1 Definitions

Commercially acceptable time is stipulated in the evidence guides to candidates provided by the NZ Hair and Beauty Industry Training Organisation Inc. Commercially acceptable time varies for different hairdressing services. Times reflect performance required for the economic viability of a trading salon. Creative means freedom to use all ideas.

Fashion means non-basic work which can include, but is not limited to, competition-type styling.

Industry techniques are those stipulated in the evidence guides to candidates provided by the NZ Hair and Beauty Industry Training Organisation Inc. Legislative requirements refer to the obligations of the employer and/or employee under the Health and Safety at Work Act 2015, Health (Hairdressers) Regulations 1980, Material Safety Data Sheets (MSDSs), Privacy Act 1993, Human Rights Act 1993, Smoke-free Environments Act 1990, Fire Safety and Evacuation of Buildings Regulations 2006, and subsequent amendments, and enterprise fire and emergency policies and procedures.

- 2 It is intended that assessment against this unit standard takes place as a part of the final stages within a programme of study or training leading towards a hairdressing qualification for a professional stylist.
- To reflect commercially acceptable time all outcomes will be assessed in two modules of three hours (total six hours) and work in progress will not be carried forward from the first module to the second module.

- In this unit standard all work must comply with legislative requirements and must ensure optimum hair condition and maximum client comfort at all times.
- Useful references for this unit standard include the *Employers' Training Manual*, and the *Training Record Book*. # Outcomes and performance criteria

### Outcome 1

Complete a fashion wind permanent wave service.

Range includes – a fashion scissor and/or razor cut, a fashion set or fashion blow wave.

### Performance criteria

- 1.1 Analyse and confirm the client's needs with the client, and determine and specify techniques and objectives relevant to needs.
- 1.2 Conduct chemical processes following industry techniques, in accordance with manufacturer's instructions and to meet the confirmed objective.
- 1.3 Fashion scissor cut and/or razor cut the hair following industry techniques and to meet the confirmed objective.
- 1.4 Fashion set or fashion blow wave the hair following industry techniques and to meet the confirmed objective.
- 1.5 Advise the client about home hair care for his or her hair type and for the service completed.
- 1.6 Record hair service and process results in accordance with salon requirements.
- 1.7 Sanitise tools and equipment in accordance with legislative requirements.

#### Outcome 2

Complete a creative multi-shading service with permanent colours.

Range includes – a fashion scissor and/or razor cut, and a fashion blow wave or fashion set not already demonstrated.

## Performance criteria

2.1 Analyse and confirm the client's needs with the client, and determine and specify techniques and objectives relevant to needs.

- 2.2 Conduct chemical processes following industry techniques, and in accordance with the manufacturer's instructions and to meet the confirmed objectives.
  - Range includes but is not limited to conducting a predisposition test for allergies.
- 2.3 Fashion scissor cut and/or razor cut the hair following industry techniques and to meet the confirmed objective.
- 2.4 Fashion blow wave or fashion set the hair following industry techniques and to meet the confirmed objective.
- 2.5 Advise the client about home hair care for his or her hair type and for the service completed.
- 2.6 Record hair service and process results according to salon requirements.
- 2.7 Sanitise tools and equipment in accordance with legislative requirements.

#### Outcome 3

Complete a complex long hair style service.

Range one of – evening style, wedding style.

### Performance criteria

- 3.1 Analyse and confirm the client's needs with the client, and determine and specify techniques and objectives relevant to needs.
- 3.2 Execute the style in a commercially acceptable time following industry techniques to meet the confirmed objective.
  - Range incorporating one or more accessories.
- 3.3 Advise the client of after service care to maintain the style.
- 3.4 Record hair service and process results in accordance with salon requirements.
- 3.5 Sanitise tools and equipment according to legislative requirements.
