- 2 Assessment against this unit standard will include evidence collected over a period of five consecutive scheduled working days. The five consecutive scheduled working days should allow for, but not include, valid absences.
- 3 Assessment against this unit standard must not be in the form of a role-play or simulation and will take place within the beauty salon or clinic where the candidate is employed or on work experience or in training.

Performance criteria

1.1 Describe facial features in terms of their different types.

Range facial features include but are not limited to – face shape, eye shape.

- 1.2 Describe skin tones in terms of their features and differences.
 - Range skin tones include but are not limited to warm, cool, ruddy, sallow.
- 1.3 Describe skin types in terms of their features and differences.

Range skin types include but are not limited to – dry, oily, combination.

1.4 Identify and describe own facial features, skin tone, and skin type in terms of their influence on personal presentation decisions.

Outcome 2

Maintain personal presentation for a beauty salon or clinic.

Performance criteria

- 2.1 Maintain skin care regime to meet the needs of own skin type.
- 2.2 Apply and maintain make up in a manner that compliments own facial features and skin tones and meets salon or clinic requirements.
- 2.3 Shape and/or paint nails in a manner that meets salon or clinic requirements.
- 2.4 Wear clothing in a manner that meets salon or clinic requirements.
- 2.5 Style and wear hair in a manner that compliments own facial features and meets salon or clinic requirements.
