# **Explanatory notes**

1 Candidates must follow any applicable and recognised codes of practice, and documented workplace health, safety, and environmental procedures for personal, product, workplace health, safety, and environmental matters, and the obligations required under current law including the Health and Safety in Employment Act 1992 and its subsequent amendments.

#### 2 Definitions

Job documentation refers to the documentation that is used in the workplace that contains the instructions and requirements for a particular production job. This may include but is not limited to workplace orders, production orders, workplace specifications, samples, lay cards.

Workplace practices refer to the documented procedures for the machine and/or workplace.

# **Outcomes and evidence requirements**

#### Outcome 1

Observe quality control methods in the fibreboard packaging industry, and solve or report problems.

#### **Evidence requirements**

1.1 The importance of maintaining high quality throughout processing is explained.

Range may include but is not limited to – job documentation, sampling, sign-off, quality checks.

- 1.2 The impact of variation in production quality is explained in terms of customer satisfaction, maintaining customer loyalty, job security, waste, and profitability.
- 1.3 Quality and technical specifications relating to the products being checked are described.

Range evidence is required for a minimum of four product variants.

1.4 Checking procedures used in the workplace are described and carried out according to the specified method.

Range evidence is required for a minimum of three different checking procedures.

- 1.5 Check results are documented in accordance with workplace practices.
- 1.6 Quality control problems are identified and solved or reported in accordance with workplace practices.

#### Outcome 2

Demonstrate knowledge of risk management in the fibreboard packaging industry.

### **Evidence requirements**

2.1 Risk factors that affect the fibreboard packaging industry are described.

Range may include but are not limited to – employee health and safety, fire safety, impact of quality, level of contamination, compliance requirements, security, confidentiality.

Workplace practices to be followed for minimising the risk factors described in evidence requirement 2.1 are outlined.

#### Outcome 3

Demonstrate knowledge of factors affecting the environment in the manufacture of fibreboard packaging product.

#### **Evidence requirements**

3.1 Three examples of environmental factors managed within the industry are identified.

Range may include but is not limited to – waste disposal, use of resources such as water and electricity, contamination, hazardous substance containment.

3.2 Waste control procedures are explained in terms of workplace practices.

Range recyclable waste, waste disposal, security waste, hazardous waste.

# 3.3 The company environmental policy statement is described in terms of workplace practices.
