Range evidence for activities from four different types of recreation contexts is required.

- 1.3 Identify and explain compliance requirements that relate to the regulatory framework for safety auditing of recreation activities.

- 1.4 Explain the implications of organisational compliance and non-compliance with the identified legislative and compliance requirements relating to safety auditing of recreation activities.

Range implications may include – liability, risk management, market positioning, health, safety, employment, privacy, environmental sustainability, public accessibility, licence to operate.
