1.1 Cleaning products, disinfectants and cleaning equipment are selected, prepared and used to clean and disinfect laundry equipment and surfaces in accordance with infection control guidelines and enterprise procedures.

1.2 Personal protective equipment is worn and/or used when cleaning and disinfecting laundry equipment and surfaces according to enterprise procedures.

# Performance criteria

- 2.1 Infection control measures are used according to enterprise procedures.

- 2.4 One way workflows from dirty to clean zones are adhered to according to infection control guidelines and enterprise procedures.

Identify and respond to infection risks in a laundry.

- 3.1 Common infection risks are identified and appropriate response implemented within scope of own role to maintain a clean environment according to enterprise procedures.
- 3.2 Personal protective equipment is worn and/or used when responding to an infection risk according to enterprise procedures.
- 3.3 Spillages are removed in accordance with enterprise procedures.
