- 2 Definitions
Information – unprocessed, raw and/or perishable material or data, that could be
 collected from any source, to be analysed and refined for decision making.
Intelligence – the functions, activities, people or organisations that are involved in the
 process of planning, gathering and analysing information that leads to the production
 of intelligence products, which are of potential value to decision makers.
Intelligence cycle – the interactive and cyclical process used to produce intelligence.
Organisational requirements – instructions to staff on policies, procedures, and
 methodologies which are documented and are available in the workplace. They must
 be consistent with applicable legislation and any other applicable compliance
 requirements.

Risk management process – the systematic application of management policies, procedures and practices to the activities of communicating, consulting, establishing the context, and identifying, analysing, evaluating, treating, monitoring and reviewing risk.

- 3 **Assessment Range**
All activities and evidence presented for outcomes and performance criteria in this unit standard must be in accordance with organisational requirements.

Evaluate the Terms of Reference for an intelligence project.

Performance criteria

- 1.1 Evaluate the aims and objectives established in the Terms of Reference for an intelligence project.
- 1.2 Evaluate the scope and parameters established in the Terms of Reference for an intelligence project.
- 1.3 Evaluate the production of the Terms of Reference.

Outcome 2

Evaluate the application of the intelligence cycle, security protocols of handling protectively marked information, analytical tools and techniques, and risk management process of the intelligence project.

Performance criteria

- 2.1 Evaluate the effect of the application of the intelligence cycle.

Range	must include – intended effect, outputs expected, lessons learnt.

- 2.2 Evaluate the application of security protocols applied to the handling of protectively marked information.
- 2.3 Evaluate the analytical tools and techniques employed in the intelligence project.
- 2.4 Evaluate the risk management process applied to the intelligence project.

Outcome 3

Produce a plan to evaluate the impact of the intelligence project.

Performance criteria

- 3.1 Define the scope and objectives of the evaluation.
- 3.2 Determine who will be involved in the evaluation and why they will be involved.
- 3.3 Outline evaluation questions and measurable outcomes to inform the evaluation process.
- Range questions and measurable outcomes may relate to – timing, resourcing, organisational factors of the response.
- 3.4 Determine the impact of the response of the intelligence project.
- 3.5 Produce an evaluation plan for the intelligence project.
