3 Definitions

Company requirements refers to instructions to staff on policy and procedures that are available in the workplace. These requirements may include – company policies and procedures, work instructions, product quality specifications and legislative requirements.

Industry guidelines refers to those practices and procedures commonly used as standard procedures to produce items of acceptable merchantable quality in the industrial textile fabrication industry such as related textbook descriptors.

Manufacturer's information refers to information such as technical information for a machine or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

Materials refers to components and sundry items required for industrial textile jobs.

Suitable tools and equipment refer to industry approved tools and equipment that are recognised within the industry as being the most suited to complete the task in a professional and competent manner with due regard to safe working practices.

Outcomes and performance criteria

Outcome 1

Confirm fabrication requirements for industrial textile fabrication jobs.

Performance criteria

- 1.1 Material requirements and availability are confirmed.
- 1.2 Staffing requirements are confirmed.
- 1.3 Space and equipment requirements are confirmed.

Outcome 2

Develop a work breakdown schedule (WBS) for industrial textile fabrication jobs.

Performance criteria

- 2.1 Sequence of tasks is specified.
- 2.2 Timing for tasks is allocated.
- 2.3 Staffing for tasks is allocated.

Outcome 3

Use a WBS to monitor industrial textile fabrication jobs.

Performance criteria

- 3.1 Actual times taken to complete tasks are compared with WBS planned times.
- 3.2 Actual staffing used to complete tasks are compared with WBS.
- 3.3 WBS is adjusted to show variance between planned and actual task.
