Guidance Information

1 Definitions

Information refers to unprocessed, raw and/or perishable material or data, that could be collected from any source.

Intelligence refers to information produced through the analysis of other information. *Organisational requirements* refer to instructions to staff on policies, procedures, and methodologies which are documented and are available in the workplace. This includes an organisation's obligations under Te Tiriti o Waitangi/The Treaty of Waitangi.

- 2 The Regulatory sector has a number of terms with specific usage. For current definitions visit <u>Programme Guidance-Skills.</u>
- 3 References include but are not limited to: Te Tiriti o Waitangi/The Treaty of Waitangi; Specific legislation mandating the powers and duties of a specific organisation with respect to its regulatory role and/or any other legislation applicable to a particular regulatory situation (e.g. Fisheries Act 1996, Resource Management Act 1991).
- 4 Range
 - Demonstration of knowledge and skills must be consistent with any applicable code or codes of conduct such as the New Zealand State Services Code of Conduct, Standards of Integrity and Conduct (available from <u>http://www.publicservice.govt.nz</u>) and/or any other agency specific code or codes of conduct and/or ethics.
 - Demonstration of knowledge and skills must come from a regulatory organisation which may be the candidate's employer or may come from a case study using simulated scenarios.
