 - Range confirm survey brief, communicate with client, landowner, neighbours and/or site supervisor, identify emergency procedures.
- 2.2 Appropriate personal protective equipment is identified and worn at all times during operations.
- 2.3 All surveying equipment is secured.

Range secured – while travelling, when unattended.

- 2.4 Access to the worksite is confirmed as meeting the requirements of legislation and workplace procedures.
- 2.5 The person in charge of the site is notified and requested to identify safety hazards on site.
- 2.6 Safe methods of working are followed in accordance with workplace procedures, legislation, and/or local/regional authority requirements.
- 2.7 The survey team's intended whereabouts are notified.
- 2.8 During property access, discretion is exercised, behaviour and activities avoid confrontation and maintain safety.
- 2.9 The property is left in a safe, tidy condition at the end of the working day.

Range within the responsibility of the candidate; may include but is not limited to – backfilled excavation, hazard warning tape, communication with occupants.
