2 Definitions

Alpine resort refers to alpine areas that are established primarily for the provision of snowsport and associated snow activities. Some alpine resorts may also provide summer operations for activities such as mountain biking, walking and guest visits. Natural and artificial features refer to the geographical features of the resort as well as man-made features such as lifts, roads, half-pipes and structures. Organisational or alpine resort policy and procedures are instructions to staff that may be documented and available for reference at each alpine resort in the form of an operations manual and/or policy and procedures manual.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of the main features and organisational operations of the alpine resort, and the products and services it provides.

Performance criteria

- 1.1 Identify and locate major natural and artificial features, and base area facilities of the alpine resort.
- 1.2 Explain products and services provided by the alpine resort in terms of how the different operations link to each other within the alpine resort.
- 1.3 Describe an alpine resort in terms of organisational structure, vision, values and staff development systems.

Outcome 2

Demonstrate knowledge of the alpine resort industry and an alpine resort's contribution to the local area.

Performance criteria

2.1 Identify key aspects of the alpine resort industry within New Zealand.

Range may include – size of workforce, career pathways, locations, seasonal activities and operations.

2.2 Describe an alpine resort's contribution to, and significance within the local area.

Range may include – cultural, social, economic, historical, recreational.
