Purpose	This unit standard relates to one's own airport fire and rescue service and its role working within a multi-agency response to an aerodrome emergency incident.
	People credited with this unit standard are able to: - describe establishment of an incident action plan (IAP) for own agency's function at a given multi-agency aerodrome emergency incident; - describe own agency's function on an ongoing basis at the aerodrome emergency incident; and - demonstrate effective communication at the incident.

Explanatory notes

- 1 Compliance with the fire and rescue service provider's Health and Safety policy and procedures and the Health and Safety at Work Act 2015 is mandatory.
- 2 Assessment against this unit standard may take place under real or practical simulation conditions.
- 3 Definitions

Agency refers to an airport fire and rescue service provider and which is working alongside any agency or agencies from – central and local government, emergency services, health services.

Fire and rescue service provider's requirements refer to policies and procedures on safety and operation set down by each fire and rescue service employer or host organisation. For this unit this will be one's own agency.

The coordinated incident management system (CIMS) is a proactive incident management framework that systematically manages incidents regardless of size, hazard, and complexity.

An *incident* is a disruption, accidentally or deliberately caused, which requires a response from one or more agency.

Incident Action Plan (IAP) is a statement of the objectives, strategies, and critical functions to be taken at the incident.

Own agency's function, for the purpose of this unit standard, refers the one of the main functions within the CIMS structure (excluding Incident Control) or a subfunction.

Outcomes and evidence requirements

Outcome 1

Describe establishment of an IAP for own agency's function at a given multi-agency aerodrome emergency incident.

Evidence requirements

- 1.1 Describe own agency's function for the incident in accordance with the CIMS structure and fire and rescue service provider's requirements.
- 1.2 Describe initial assessment of the incident in terms of initial planning.

Range liaison with incident controller, aim, strategy, tactics, resources,

other agency functions;

may include but is not limited to – assembly area, casualty

clearing point, emergency operations centre, incident control point,

inner cordon, outer cordon, safe forward point, staging area.

Outline IAP content based on own agency's function (1.1), the initial assessment (1.2) of the aerodrome emergency incident, and in accordance with fire and rescue service provider's requirements.

Outcome 2

Describe own agency's function on an ongoing basis at the aerodrome emergency incident.

Evidence requirements

- 2.1 Describe own agency's ongoing function for the incident in terms of review, continuation, situation reporting, and hazard and risk assessment.
- 2.2 Describe problems that may occur and how these may be addressed in terms of CIMS and fire and rescue service provider's requirements.

Range may include but is not limited to – communication, tactics, resource deficiency.

Outcome 3

Demonstrate effective communication at the aerodrome emergency incident.

Evidence requirements

3.1 Communicate in response to tactical requirements and changing situations and problems.

Range changing situations and problems may include but are not limited

to - hazards, radio or other equipment failure.

3.2 Information is conveyed in accordance with fire and rescue service provider's requirements.

Range may include but is not limited to – correct terminology, clarity,

precision, calmness, pronunciation, critical spelling.
