## **Guidance Information**

#### 1 Definitions

Action plan refers to a planned steps or task, or a process for a specific project that will be completed over a set period of time to achieve a particular objective. Collaborate refers to two or more people working together by sharing and thinking valuable ideas towards the accomplishment of a common objective. Project team refers to a group of individuals responsible for carrying out the plan in relation to the project.

## 2 Assessment information

Collaboration within the team is expected to meet team members' and company expectations for personal and team behaviour.

For the purposes of assessment, the project should be based on marine or composite activities, processes, or multi-step tasks that have to be completed over a set period of time, such as installation of pipework in a boat, a boat construction project, production of a cored laminate product, or a bisphenol resin product. It is expected that the team will successfully complete the project.

# **Outcome 1**

Collaborate within a project team in the marine or composite industry.

## Performance criteria

1.1 Purpose of the team and agreed interactions between team members are verified in relation to the action plan.
