1 Legislation

Residential Tenancies Act 1986; and all subsequent amendments and replacements.

2 Definition

Landlord refers a person who has offered to grant tenancy to any other person, or who has entered into negotiations with any other person for the granting of a tenancy to that person.

## Outcome 2

Demonstrate and apply knowledge of forms used in the bond process.

Range bond lodgement form, change of tenancy form, change of landlord, bond transfer form.

### Performance criteria

- 2.1 Describe situations that require the various bond forms.
- 2.2 Complete and explain the processes of each form in accordance with the Residential Tenancies Act 1986.

#### Outcome 3

Prepare and complete applications and explain the process for managing bond disbursement and bond disputes.

#### Performance criteria

- 3.1 Prepare and complete an application for disbursement of an undisputed bond and explain the subsequent stages of the application and the process of dispersing the bond to the relevant party.
- 3.2 Prepare and complete an application for disbursement of a disputed bond and explain the subsequent stages of the application and the process of dispersing the bond as you would to the relevant party.
- 3.3 Prepare and complete an application for disbursement of a single-party claim, explain the subsequent stages of the application and the process of dispersing the bond to the relevant party.
