Guidance Information

- 1 This unit standard can be awarded with an Achieved, Merit, or Excellence grade. For the Achieved grade to be awarded, the outcome must be achieved as specified in the outcome statement. For Merit or Excellence grades to be awarded, the candidate must meet the Merit or Excellence criteria specified above.
- 2 *Vagahau Niue* refers to the authentic language of Niue as communicated in the Pacific island nation and in New Zealand.
- 3 This unit standard is derived from the Learning Languages learning area, Communication, Language Knowledge, and Cultural Knowledge strands Curriculum Level 7 of *The New Zealand Curriculum*, Learning Media, Ministry of Education, 2007, and is related to the *Tau Hatakiaga ma e Vagahau Niue: The Niue Language Guidelines* (<http://pasifika.tki.org.nz/Pasifika-languages/Vagahau-Niue>) and the material in the *Teaching and Learning Guide for Languages*, Ministry of Education at <http://seniorsecondary.tki.org.nz>.

- 4 It is recommended that:
- i the outcomes are assessed as part of an integrated unit of work, relevant to the learning context of the candidate;
 - ii assessment be conducted in conjunction with assessment against other Vagahau Niue unit standards at this level.
- 5 Each spoken text for this unit standard:
- i may be up to two minutes in length;
 - ii must be appropriate to the spoken mode or a text which is designed for oral delivery;
 - iii must be delivered in clear standard speech in a familiar accent;
 - iv may include distinct and differentiated voices, for example, female and male, youthful and mature;
 - v may be heard as a whole, and in sections, with a pause after each section;
 - vi may be presented face to face, or in pre-recorded audio or audio-visual format. If audio-visual materials are used, these must not include large amounts of written text.
- 6 Definition
- On familiar matters* refers to regularly encountered information, ideas and opinions that will be expressed in clear standard aural Vagahau Niue, for example: tau amaamanakiaga haaku (my future plans), magafaoa haaku he tau motu kehe (my family in other countries) tau mena kai haaku ne fiafia ki ai (food which I like) and tunu kai afiafi (cooking dinner), fakaaoga he bank card (using a bankcard), laga vaka (wakaama/rowing), koli moe lologo (sing and dance), koe feua mahuiga (my favourite event), tau pulotu he tau mamatua (the wisdom of the elders).

Outcomes and performance criteria

Outcome 1

Demonstrate understanding of a variety of spoken Vagahau Niue texts on familiar matters.

Range spoken texts that relate to familiar matters may include – media extracts or reports on topics of personal and/or community interest, conversations, narrated extracts from short stories, public address announcements, sports commentary; a minimum of three different text types is required.

Performance criteria

1.1 A written response to each text is given in either English, te reo Māori and/or Vagahau Niue that demonstrates understanding by making meaning of the information, ideas and opinions in the texts.

Range a written response may include but is not limited to –
 clarifying information, ideas and/or opinions;
 summarising information, ideas and/or opinions;
 producing, annotating, amending, or completing visual representations of ideas e.g. maps, sketches, diagrams;
 rephrasing Vagahau Niue statements for a different and/or specific purpose e.g. making a recommendation, giving advice.
