4 Definitions

Agencies/services refer to organisations and groups that can provide practical support, advice, resources and contacts such as Ministry of Education, Ministry of Social Development, Work and Income, Ministry for Children, Whānau Ora, ECE services, Plunket, Strategies with Kids – Information for Parents (SKIP), KiwiFamilies, Kidshealth, Citizens Advice Bureau, Refugee Centre, Ministry of Health and Public Health Services, support groups for young parents, family networks and other specialist support groups.

Networks refer to support groups for young parents, family.

Whānau/families may be parents, guardians, and members of the extended family who have an interest in the child.

Young children in this standard refers to an infant, toddler or young child from birth to school entry age. There are three broad overlapping age ranges for mokopuna/children as defined in *Te Whāriki* as: infant – birth to 18 months;

toddler – one year to three years;

young child - two and a half years to school entry age.

 Legislation and Conventions include but are not limited to: Care of Children Act 2004 Children's Act 2014 Oranga Tamariki Act 1989 or Children's and Young People's Wellbeing Act 1989 Privacy Act 2020 United Nations Convention on the Rights of the Child (UNCRC) 1989 and subsequent amendments.
