### **Guidance Information**

Learners for this unit standard should be familiar with the intent of Te Tiriti o Waitangi, which informs guidelines, procedures, and practices in the ECE sector. Assessment evidence for this standard may include examples of the underpinning of Te Tiriti o Waitangi and threading te reo Māori and tikanga Māori and exploring te ao Māori perspectives of care of young mokopuna/children, and a range of ECE services and philosophies in Aotearoa New Zealand.

ECE philosophies refer to Kindergarten, Montessori, Bilingual Education Service, Playcentre, Rudolf Steiner, Kōhanga Reo, Pacific based philosophies, Christian based philosophies, Reggio Emilia; Resources for Infant Educarers (R.I.E.), Forest Kindergartens, Language nests.

ECE service types refer to home-based, parent-led, centre-based (fulltime or sessional), hospital-based, Te Aho o Te Kura Pounamu/The Correspondence School, Ngā puna kōhungahunga and other certificated playgroups.
