- 3 Definitions

Crop protection plan refers to a workplace plan to protect crops from plant health challenges. The plan must be consistent with regulatory requirements and quality standards of the target market. The crop protection plan must comply with health and safety legislation and be consistent with the workplace health and safety plan. *Horticulture crop* may refer to an indoor crop, outdoor crop, nursery crop, fruit crop, or grape vine crop.

Quality standards are industry accepted standards for the production of horticultural crops. If the workplace is producing food, then food safety standards are included. Examples include Hazard Analysis and Critical Control Points (HACCP), Global Good Agricultural Practice (GLOBALG.A.P.), New Zealand Good Agricultural Practice (NZGAP), Japanese Agricultural Standard (JAS), BioGro, Country of Origin Labelling (COOL), International Organisation for Standardisation (ISO), Sustainable Winegrowing New Zealand (SWNZ).

Regulatory requirements are local, national, or international requirements with legal status. If the workplace is producing food, then the Food Act 2014 is included. *Workplace procedures* refer to verbal or written instructions to staff on procedures for the worksite and equipment. Workplace procedures must comply with health and safety legislation and be consistent with the workplace health and safety plan.

Outcomes and performance criteria

Outcome 1

Implement and monitor a horticulture crop protection plan.

Range evidence of one or more crop cycle is required.

Performance criteria

- 1.1 Interpret a crop protection plan.
- 1.2 Supervise crop monitoring activities in accordance with crop protection plan.
- 1.3 Monitor crop protection activities to ensure consistency with the plan.
- 1.4 Implement procedures to minimise negative environmental effects of crop protection activities in accordance with the plan.
- 1.5 Record crop protection activities in accordance with the plan.
- 1.6 Report on implementation of the crop protection programme.
