### Guidance Information

- Legislation relevant to this unit standard includes: Health and Safety at Work Act 2015, Water Services Act 2021, Resource Management Act 1991, Hazardous Substances and New Organisms (HSNO) Act 1996, and subsequent amendments.
- Definitions  
*Critical control point* – specific point, procedure, or step in water treatment processes at which control can be exercised to reduce, eliminate, or prevent the possibility of a public health hazard.  
*Effluent* – treated wastewater which is the used water from domestic, commercial, and industrial activities which contains contaminants such as nutrients, organic matter, and micro-organisms; and excludes stormwater.  
*Industry requirements* include manufacturers' specifications; and enterprise requirements which may include documented workplace policies, procedures, specifications, business, and quality management requirements relevant to the workplace in which assessment is carried out.  
*Optimise* – adjusting plant input variables to make the process as effective as possible to achieve the desired output, taking into account the constraints of cost, human input, effluent quality, and resource consent requirements.  
*Wastewater* may include stormwater and sewage systems.

## Outcomes and performance criteria

### Outcome 1

Manage effluent disinfection processes in wastewater treatment.

#### Performance criteria

1.1 Disinfection process variables are managed to achieve the desired parameters and maintain process performance.

Range intake and discharge indicator organism counts, equipment, consumables.

### Outcome 2

Monitor effluent disinfection processes in wastewater treatment.

Range may include but is not limited to – viable indicator organisms, pathogen survival, clarity, turbidity; evidence is required for three processes.

#### Performance criteria

2.1 Sampling is managed to ensure samples are collected.

2.2 Data is collected and interpreted in accordance with effluent disinfection processes.

### Outcome 3

Optimise effluent disinfection processes in wastewater treatment.

#### Performance criteria

3.1 The effluent disinfection process variables and operating factors are adjusted for optimisation of the process in accordance with the results of monitoring.

3.2 The critical control points in effluent disinfection processes are managed.
