 - Range includes but is not limited to Ministry of Business, Innovation, and Employment, Building Practitioners Board, Standards New Zealand, Building Consent Authorities, trade or professional associations, industry training organisations.

3.5 Outline the roles and responsibilities of stakeholders involved in the building's construction.

Range included but is not limited to – owner, developer, roofing company,

project manager, main contractor, building tenant.

Explain own requirements and responsibilities when working with other trades including the need for good communication.
