- 1 Evidence requirements must be consistent with all relevant legislation and subsequent amendments; this includes but is not limited to:
 - Workplace procedures
 - Health and Safety at Work Act 2015
 - Animal Products Act 1999.
- 2 Definition
Workplace procedures refer to policies and procedures on safety and operation set down by the employer or host organisation when working on a meat processing operation.
- 3 Hand held cutting equipment includes but is not limited to – cutter (brisket, hock, whizz knife); saws – scribe saw.
 Hand held cutting equipment excludes – splitting saw.

Outcomes and evidence requirements

Outcome 1

Use hand held cutting equipment to carry out a range of meat processing activities under close supervision.

Evidence Requirements

- 1.1 Use personal protective equipment.
- 1.2 Check hand held cutting equipment for safety and functionality prior to use.

- 1.3 Operate hand held cutting equipment effectively, efficiently, safely, and according to manufacturer's operating instructions.
- 1.4 Clean and store hand held cutting equipment after use according to manufacturer's instructions.
- 1.5 Report any problems relating to hand held cutting equipment and its use.
