- 2 Definition
Workplace procedures refer to policies and procedures on safety and operation set down by the employer or host organisation when working in yards on a meat processing operation.
- 3 All stock handling activities should be carried out consistent with the relevant animal welfare code guidelines.

Outcomes and evidence requirements

Outcome 1

Carry out stock handling activities in a meat processing operation under close supervision.

Evidence Requirements

- 1.1 Use personal protective equipment while carrying out tasks.
- 1.2 Assist to unload stock from transporter without causing undue stress to stock.

- 1.3 Assist to move groups of stock between yards without causing undue stress to stock.
- 1.4 Assist to move stock along raceways without causing undue stress to stock.
- 1.5 Clean stock according to species requirements.
- 1.6 Identify and report unwell, sick or injured stock.
- 1.7 Clean yards as required.
- 1.8 Check and report water availability for stock.
