#### **Guidance Information**

1 Definitions

Cargo may include but is not limited to – dangerous goods, general freight, high value items, human remains, live animals, perishable items, unaccompanied baggage, vehicles or weapons.

Organisational procedures refer to the step-by-step instructions for implementing or carrying out an organisation's policy or desired objective.

- 2 All activities must be carried out in accordance with organisational procedures.
- 3 Legislation
  - a Any relevant Acts, regulations, and bylaws must be complied with during assessment against this standard.
  - b Legislative and/or regulatory requirements must include but are not limited to the Civil Aviation Act 1990 and all subsequent amendments and replacement.
- 4 Evidence for the practical components of this standard must be gathered in an aviation workplace.

# Outcomes and performance criteria

#### **Outcome 1**

Prepare to retrieve air cargo.

#### Performance criteria

- 1.1 Despatch area is prepared to receive cargo.
- 1.2 Equipment and resources are checked and the appropriate action taken where required.

Range may include but is not limited to – fit for purpose, available, sufficient quantities.

1.3 Cargo release priorities are determined in accordance with service levels.

Range may include but is not limited to – notification for delivery, delivery receipt.

1.4 Release is co-ordinated with the consignee or their authorised representative.

#### Outcome 2

Retrieve air cargo.

#### Performance criteria

- 2.1 Cargo is located and retrieved.
- 2.2 Cargo is inspected for irregularities and the appropriate action taken.

Range irregularities may include but are not limited to – surplus cargo, missing cargo and pillage, bio-security hazard(s).

2.3 Details of the cargo and consignee or their authorised representative are verified.

#### **Outcome 3**

Release air cargo.

### Performance criteria

- 3.1 Cargo is released to the consignee or their authorised representative.
- 3.2 Details of the cargo released is recorded.
- 3.3 Despatch area is cleaned, tidied and equipment left ready for use.
