2 Assessment

Assessment must be conducted in the context of a real or realistic horticulture organisation, consistent with the requirements of that organisation. A *horticulture organisation* can be business, or a commercial or other enterprise, not necessarily for profit, and can be a business unit within a larger organisation. The organisation must be sufficiently complex to enable demonstration of the full range of competence for achievement of the outcome.

3 Definition

Environmental sustainability is the rates of renewable resource harvest, pollution creation, and non-renewable resource depletion that can be continued indefinitely. If they cannot be continued indefinitely then they are not sustainable.

Outcomes and performance criteria

Outcome 1

Describe the impact of legislation on environmental sustainability relevant to a horticulture organisation.

Performance criteria

1.1 Describe the way in which legislative compliance impacts on environmental sustainability in terms of implications for a horticulture organisation.

Outcome 2

Analyse the impacts of a horticulture organisation on the environment, and recommend environmentally sustainable solutions.

Performance criteria

2.1 Analyse policies and procedures in terms of environmental sustainability in a horticulture organisation.

Range

policies and procedures may include but are not limited to – water use and management, agrichemical use, fertiliser use, nutrient management, run off; evidence of two policies and procedures is required.

2.2 Analyse day-to-day business practices relating to environmental sustainability compliance in terms of their impacts on the environment in a horticulture organisation.

Range

practices may include but are not limited to – water use and management, agrichemical use, fertiliser use, nutrient management, run off; evidence of two practices is required.

2.3 Recommend alternative solutions for environmentally sustainable policies, procedures, and business practices in terms of improving public and stakeholder perception, and the horticulture organisation.

Range evidence of two recommendations is required.
